Notice is hereby given that the Board of Directors of Harris County Municipal Utility District No. 102 will hold a **special meeting**, open to the public, at **6:00 p.m.** on **WEDNESDAY**, **6 SEPTEMBER 2017**, at **15300 Falmouth**, **Harris County**, **Texas**, inside the boundaries of the District, to consider and act upon the following matters:

- 1. Consider comments and questions from District residents (5 minute per person limit);
- 2. Minutes of the meetings of 24 July and 7 August 2017;
- 3. Security Report (Harris County Sheriff's Department);
- 4. Solid Waste Collection Report (contract expires 4/30/19; 60-day notice);
- 5. Report of the Tax Assessor/Collector, including:
  - (a) approve payments from the District's tax account;
  - (b) review and authorize actions for the collection of delinquent taxes, including possible termination of service;

  - (a) operation of the District's facilities and status of Wastewater Treatment Plant;

  - (g) authorize actions related to Hurricane Harvey flooding event, including requests for public assistance to FEMA:
  - (h) review packet for new customers of the District;

  - (a) report regarding maintenance of Concord Colony, Section Two and Waldron Estates detention facilities, including renewal of Storm Water Quality permits;
  - (b) status of spot recoating of ground storage tanks at Water Plant No. 1 (Blastco, Inc.) and authorize actions deemed necessary;
  - (c) status of TCEQ Sanitary Sewer Overflow Initiative and authorize actions deemed necessary;
  - (d) status of televised inspection of sanitary sewer lines in Area B Phase 1 (Magna-Flow Environmental, Inc.), including status of final pay estimate:

  - (a) status of surface water issues related to West Harris County Regional Water Authority;
  - (b) discuss power supply issues (P3);
  - (c) status of issues related to District's web site, including review of content;
  - (d) discuss landscaping issues, and authorize actions deemed necessary;
- 11. Attorney's Report, including approval of certified agenda of 26 June 2017 executive session;
- 12. Executive session pursuant to Open Meetings Act, Chapter 551, Government Code, if necessary, to discuss matters relating to pending or contemplated litigation, personnel matters, real estate transactions, or security;
- 13. Action on matters discussed in executive session;
- 14. Schedule future meetings as required; and
- 15. Discuss items to be placed on future meeting agendas.
